



# **GRACE Catholic Schools Enrollment Contract**

Academic Year 2024-25

GRACE School: Father Allouez Catholic School

Grades/Program: K - 8

In compliance with the GRACE enrollment process, Parents/Guardians are responsible for fulfilling several commitments as part of the investment in their child's educational costs.

## **General Tuition Requirements**

Your tuition payment is composed of the following charges as provided for in the respective schedules and determined by the child's enrollment:

- Enrollment Fee
- Tuition
- Activity Fee
- Technology Fee

### **Family Engagement**

GRACE schools work together in many ways to make Catholic education affordable. Each school establishes engagement opportunities and participation requirements for families as part of their commitment to their child/ren's education.

Family/parental engagement and participation is a shared responsibility in which

- our GRACE schools are committed to reach out and engage family/parents in meaningful ways; and
- families/parents are committed to be active participants in the school community and support their children's spiritual and academic growth.

Family engagement, in almost any form, creates better outcomes for students and builds community invested in the well-being of our schools, students, and families.

- Expectations are per family, per school. If selected, a buyout fee per category is per family and only
  one buyout fee per category will be added to the family's tuition and fees payment plan.
- Families with children enrolled in both preschool and K-8 grades are to follow the school's expectations for grades K-8.

#### 1. SCRIP Agreement

SCRIP is a fundraising gift card program. I/We commit to one of the following:

- A. My family elects to participate and raise \$200 in SCRIP profits by May 1, 2025.
  - Only SCRIP purchases made between July 2024 through April 2025 via the RaiseRight App will count towards a family's SCRIP profits. This is to streamline processes for tracking purchases and ensure families have just-in-time access to knowledge of their progress towards meeting the requirement.
  - Should profits greater than \$200 be achieved, 50% of the profits will be applied as a tuition credit (the remaining 50% is allocated to the Site Advisory Council in support of the school).
  - If a child is in 8th grade, tuition credits may be applied to Chesterton Academy of St. John Paul II Classical School or Notre Dame Academy for the subsequent academic year.
  - o No refunds are provided for families not returning to GRACE.
  - o Unfulfilled profit will be billed and must be paid by June 1, 2025.

B. My family elects to opt out of the program and agree to pay the \$200 buyout fee which will be added to my tuition and fees payment plan.

#### 2. Volunteer Hours Agreement

Time spent serving in various ways to support school needs and activities. I/We commit to one of the following:

- A. My family elects to participate and volunteer 15 hours between May 2024 and April 2025. I will enter my hours in the school's electronic tracking system by April 30, 2025. Unfulfilled Volunteer Hours will be billed at a rate of \$25/hour and must be paid by June 1, 2025.
- B. My family elects to opt out of Volunteer Hours and agrees to pay the \$375 buyout fee which will be added to my tuition and fees payment plan.

#### 3. TSF Hours Agreement

Time spent serving with Site Advisory Council led, third-source fundraising (TSF) events/activities which generate revenue for the school. I/We commit to one of the following:

- A. My family elects to participate and serve 5 hours supporting the school's annual fundraiser. I will enter my hours in the school's electronic tracking system within 30 days of the school's annual fundraiser. Unfulfilled TSF Hours will be billed at a rate of \$50/hour and must be paid within 60 days of the school's annual fundraising event.
- B. My family elects to opt out of TSF Hours and agrees to pay the \$250 buyout fee which will be added to my tuition and fees payment plan.
